## Workshop October 03, 2023

Members Present: Mayor James Coachman, Michael Capehart, Angela Hackney, Van Granger, and George Stringer

Mayor Coachman opened the meeting at 6:00 P. M. leading the prayer followed by the Pledge of Allegiance.

Cottonwood Ambulance & Rescue used 13,177 gallons of water for the month of September.

Announcement of the Second Congressional Distrist Municipal Association Dinner will be November 1<sup>st</sup>, 2023. Deadline to attend October 20, 2023.

Discussion on spraying insulation at the Old Town Hall and the Community Room (1414 Metcalf St). 2 quotes were received: (1) Old South Insulation and Company estimate at \$18,200.00 and (2) Blue Deese Construction estimate at \$28,780.00. If you decide to vote, it will be a roll call vote. Council Member Granger replied, "let's go ahead and vote." Council Member Capehart, Hackney, and Stringer were undecided and asked to be moved for further discussion. Motion granted to be moved.

Pastor Stan Sullivan spoke to the council and Mayor about two issues. The first issue concerns the water department employee.
