## **Council Meeting**

### **December 21, 2021**

Mayor Coachman opened the meeting at 6:00 P. M. followed by prayer then by the Pledge of Allegiance.

Council Member Capehart made a motion to waive the reading of the minutes from council meeting on November 16<sup>th</sup> and workshop on December 07<sup>th</sup> and except the minutes as presented. There was a second by Council Member Stringer and the motion was approved unanimously.
